## AMATEUR ATHLETIC WAIVER AND RELEASE OF LIABILITY

In consideration of being allowed to participate in any way in the ST MICHAEL'S PICKLEBALL ASSOCIATION Athletics/Sports Programs, and related events and activities, the undersigned:

1. Agrees that prior to participating, he/she each will inspect the facilities and equipment to be used, and if he/she believes anything is unsafe, will immediately advise the directors of the games and refuse to participate.
2. Certifies that he/she does not have a health problem or condition which would make participation in such events or activities detrimental to his/her health.
3. Acknowledges and fully understands that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions or negligence but the actions, inactions or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to me or reasonably foreseeable at this time.
4. Assumes all risks and accepts personal responsibility for the damages following such injury, permanent disability or death.
5. Releases, waives, discharges and covenants not to sue ST MICHAEL'S OR ST MICHAEL'S PICKLEBALL ASSOCIATION, its directors, officers, partners, affiliated clubs, their respective administrators, directors, agents, coaches, instructors, and other members of the association, other participants, any person acting on behalf, or any person performing duties for the association, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event, all of which are hereinafter referred to as "Releasees", from any and all liability as to each of the undersigned, together with his or her heirs and next of kin, for any and all claims, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the Releasee or any third party in connection with the athletics/sports programs and related events and activities set forth above.
6. This Waiver and Release shall remain effective until I deliver to the St. Michael's Pickleball Association written notice of its withdrawal by U.S. certified mail, the manner of delivery being a material part of such withdrawal.

St. Michael's was first introduced to this budding sport through neighbors at Carlsbad by the Sea (CBTS). In the fall of 2013 residents of CBTS were in search of a place to play their beloved sport. The two communities partnered to resurface and paint two pickleball courts in St. Michael's north parking lot.

Residents played regularly, and parishioners and clergy began to take notice! As St. Michael's began to imagine professional courts in its vacant parcel, leadership learned (through another church partnership) of a grant opportunity through the Carlsbad Charitable Foundation. In the spring of 2015, the Foundation awarded St. Michael's \$23,400 for the establishment of two professional pickleball courts!

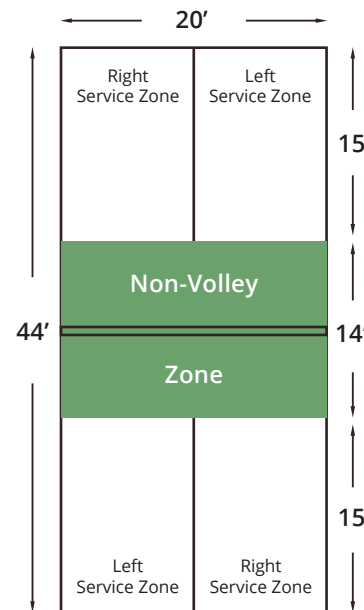
